8. Chairman's Report including Performance Report

Good evening, ladies and gentlemen and life members. It is my great privilege to table this my second annual report as the Chair of the Upper Clutha A&P societies Board of Trustees.

The 2022 no show takes its place in our history books as the first show in 77 years not to go ahead. In fact, it has only been the second world war that has stopped the show until now.

Certainly not an achievement I wanted under my chairmanship, but I take solace in the fact that the discussion was taken out of my hands by a government mandate therefore not a board decision.

I would like to mention the incredible support the at we received from members and locals alike as we grappled with the possibility of cancelling the show.

Also, a huge thanks to Jane and her management team for constantly communicating with our customers and suppliers alike as we rode the traffic like wave over the Christmas period.

We all felt quite flat during March having missed out on energy and excitement of our show.

A big thanks to those members and volunteers that turned out to celebrate the show weekend by painting show jumps, repairing stock yards etc. A great opportunity to get ahead of the game for next year.

I am sure you are all aware of the huge expenses involved in setting up the show. The cancellation created large non-recoverable costs that needed to be paid.

We were fortunate enough however to meet the criteria for the Government's ETSP scheme. Event underwriting provided by the government.

I am pleased to announce that we received a significant payment that has covered most of our non-recoverable costs.

I am also pleased to announce tonight that on the back of the ETSP payment our books have stayed in the black for the 2022 financial year posting a small surplus that is after adjustments for a 2021 grant from QLDC for traffic management and the sale of security gates owned by the show but used by Stalker Fencing each year.

Our accounts are slow to get to the auditors again this year with a change in personnel and the ETSP payment still being up in the air around our balance date.

The final accounts have been processed by our local accountant and soon to go to the auditors. Copies of the accounts will be available on the Charities website as soon as the audit is complete.

Covid has demonstrated just how vulnerable we are as a society running the show with large upfront costs. We really rely on the size of the walk-up crowd over the weekend to determine the profit or loss of the event.

The board is continuing to revise our financial plan to mitigate this risk, while looking at fair and reasonable ways to share the risk with all our stakeholders.

I believe we have the ideal personnel on our board to critique our plan, but we are not opposed to seeking professional advice.

One change we recently made was to bring the management of trade and finance back in house. We contracted this role out during the establishment of the board at the request of the management team. Unfortunately, it hasn't worked to the board's satisfaction and the move back in house is designed to create a more conducive management team operating within one office.

Sadly, we lost Bronwyn McCarthy through this process. Bronwyn has been with the show for 15 years and her experience and expertise will leave a big gap to fill.

I would like to record a huge thanks to Bronwyn for her dedication and thoroughness that saw the show grow from the show grounds out and across Pembroke Park, right out to the edge of the CBD.

Thank you, Bronwyn.

We have employed Gina Treadwell in a part time position to join Jane and Fe in the office as the management team. Gina will manage the bulk of the trade and finance work but with subtle responsibility changes within the office to improve outcomes for the society.

Gina couldn't be with us tonight. She is on a family holiday, organized before she came onboard.

Our land use consent to allow us to extend our building is progressing slowly. We are about to commission a Geotech report to confirm that the ground is suitable to build on. This I hope is the last of the hurdles we have had to jump through in a very long and arduous process. Once we have our land use consent in place, we will have five years to finalise design,

organise funding and hopefully proceed with the build.

After the 2023 show there will be a wetlands development starting behind the pavilion, this is a council project within the paper road corridor between the reserve and the sections in Meadowstone. The net effect to the society is that we will lose the area behind the pavilion including the bar.

This development has been pushed through non-notified and at the time of writing only Friends of Bullock Creek were showing any interest in challenging it. We have looked closely at what our options are, but, the work is happening outside of our show lease.

More concerning is QLDC plans to exclude all activities on the two playing fields over this summer while they install drainage, replace recently installed irrigation and returfing the playing fields.

We have not been consulted on this work and considering the normal delays on council projects we have a real concern that the main ring could be out of use during the show. Both cricket and rugby clubs are opposed to the work proceeding this spring/summer and collectively we are asking council for assurances on availability of the grounds before the 1st March. Very happy to accept extra support in this matter.

This year's board election was completed on Monday, and I would like to take this opportunity to thank all our nominees for putting their names forward. We would have been delighted to have any combination joining our Board and so sincerely thank you all for standing.

I can now confirm that Dell Taylor will be joining the board as a new board member, and I will continue in my role as an existing board member for another term.

Thank you to Chrissy Gibson who has been with the board since its inception. Chrissy has managed our scholarship programme and also been instrumental in getting many of our major sponsors on board.

Unfortunately, Chrissy can't be here tonight to receive a small gift from us in recognition of her work on the board. But I'm sure we will see her around showtime as she is an enthusiastic supporter of the show.

Thank you, Chrissy.

Finally this will be my last Chairperson report, I have enjoyed my time immensely and have been very proud to be part of these significant changes in the Society's structure, I think we are in a very strong position to move forward and continue to hold a important place in Wanaka's event calendar, as well, I think we can grow as a Society and challenge our direction and look at other opportunities to showcase our rich rural diversity.
